## WHEN TO USE

Apply to bare ground or when weeds are present. If weeds are taller than six inches, mow or cut down weeds and remove debris before treatment. To prevent growth of weeds under asphalt driveways, play areas, tennis courts and parking areas, apply this product before laying surfacing materials. Treat area uniformly to maximize results.

Re-treatment every 6 to 8 months may be necessary in areas of heavy rainfall.
