Do not apply this product in a way that will contact adults, children, or pets, either directly or through dults. Do not allow adults, children or pets to enter the treated area until dusts have settled. Do not apply to trees.

To control certain insects and to control or prevent certain blight, leaf spots, mildew and certain other diseases on listed plants. Use as a dust any time conditions are favorable, as soon as plants are above the ground or as soon as insects appear. Keep foliage covered, especially new growth.

For insects apply when insects appear. Young insects and larvae are usually easier to control than adults. When blossoms are in full bloom, protect pollinators by using a fungicide only, such as Bonide® Copper Dust. For disease, applications should begin well before they are expected to appear.
