SECTION 2: HAZARD IDENTIFICATION

EMERGENCY OVERVIEW

CAUTION: This product is a colorless/pale yellow thin liquid with a fresh-scent fragrance. Direct contact with eyes can cause irritation. Ingestion of large amounts may cause some gastrointestinal discomfort including nausea, vomiting and diarrhea. Repeated or prolonged contact with skin may cause irritation or dermatitis. Keep out of reach of children. No significant environmental effects. Not a fire hazard. Product is stable.

POTENTIAL HEALTH EFFECTS

SECTION 4: FIRST AID MEASURES
