### 2. Hazard Identification

EMERGENCY OVERVIEW: Extremely flammable liquid and vapor. Vapors may cause flash fire or explosion. Harmful if inhaled. May affect the brain or nervous system causing dizziness, headache or nausea. ### 4. First-aid Measures
