## VII. SPILL OR LEAK PROCEDURES

STEPS TO BE TAKEN IN CASE MATERIAL IS RELEASED OR SPILLED: Remove all sources of ignition (flames, hot surfaces and electrical, static or frictional sparks). Avoid breathing vapors. Ventilate area. Use non-sparking tools. Remove with inert absorbant.

WASTE DISPOSAL METHOD: Dispose of in accordance with local, state, and

federal regulations. Do not incinerate closed containers.

### VIII. SPECIAL PROTECTION INFORMATION

- RESPIRATORY PROTECTION: For casual use none required. To avoid breathing vapors or spray mist, open windows and doors or use other means to ensure fresh air entry during application and drying. If you experience eye watering, headaches or dizziness, increase fresh air or wear respiratory protection (NIOSH/MSHA approved) or leave the area. Avoid contact with eyes, skin and clothing.
- VENTILATION: Provide general dilution or local exhaust ventilation in volume and pattern to keep TLV and LEL of most hazardous ingredient in Section II, below acceptable limit.
- PROTECTIVE GLOVES: Permeation resistant gloves (butyl rubber, nitrile rubber) should be used. Cover as much of the exposed skin area as possible with appropriate clothing.

### IX. SPECIAL PRECAUTIONS

PRECAUTIONS TO BE TAKEN DURING HANDLING AND STORAGE: Do not store above 120 degrees F. Store large quantities in buildings designed and protected for storage of NFPA Class 1A flammable liquids. Keep away from heat. Keep away from sparks, flames, and other sources of ignition. Do not store near strong oxidizing agents or strong acids. This material may cause sensitization. Do not get in eyes, on skin or clothing. Do not allow contaminated clothing to contact skin. Avoid breathing vapor or mist. Use with adequate ventilation. Use explosion proof equipment. Follow all MSDS/label precautions even after the container is emptied because it may retain product residues. Wash thoroughly after handling.

OTHER PRECAUTIONS: Do not spray in eyes. Do not puncture or incinerate cans. Do not stick pin or any sharp objects into opening on top of can. Finger must not protrude over spray button. This product contains no reportable Hazardous Air Pollutants.
