## Section 3 - Hazards Identification

\*\*\* Emergency Overview \*\*\*: Contents Under Pressure. Harmful if inhaled. May affect the brain or nervous system causing dizziness, headache or nausea. Vapors may cause flash fire or explosion. Harmful if swallowed. Extremely flammable liquid and vapor.

Effects Of Overexposure - Eye Contact: Causes eye irritation.

Effects Of Overexposure - Skin Contact: Prolonged or repeated contact may cause skin irritation. Substance may cause slight skin irritation.

Effects Of Overexposure - Inhalation: High vapor concentrations are irritating to the eyes, nose, throat and lungs. Avoid breathing vapors or mists. High gas, vapor, mist or dust concentrations may be harmful if inhaled. Harmful if inhaled.

Titanium Dioxide is listed as a Group 2B-"Possibly carcinogenic to humans" by IARC. Significant exposure is not anticipated during brush application or drying. Risk of overexposure depends on

duration and level of exposure to dust from repeated sanding of surfaces or spray mist and the actual concentration of Titanium Dioxide in the formula.

May cause central nervous system disorder (e.g., narcosis involving a loss of coordination, weakness, fatigue, mental confusion, and blurred vision) and/or damage. Reports have associated repeated and prolonged occupational overexposure to solvents with permanent brain and nervous system damage. Overexposure to xylene in laboratory animals has been associated with liver abnormalities, kidney, lung, spleen, eye and blood damage as well as reproductive disorders. Effects in humans, due to chronic overexposure, have included liver, cardiac abnormalities and nervous system damage.

## Section 4 - First Aid Measures

First Aid - Eye Contact: Immediately flush eyes with plenty of water for at least 15 minutes holding eyelids open. Get medical attention. Do NOT allow rubbing of eyes or keeping eyes closed.

Unusual Fire And Explosion Hazards: Keep containers tightly closed. FLASH POINT IS LESS THAN 20 °. F. - EXTREMELY FLAMMABLE LIQUID AND VAPOR! Perforation of the pressurized container may cause bursting of the can. Water spray may be ineffective. Closed containers may explode when exposed to extreme heat. ## Section 6 - Accidental Release Measures

Steps To Be Taken If Material Is Released Or Spilled: Remove all sources of ignition, ventilate area and remove with inert absorbent and non-sparking tools. Contain spilled liquid with sand or earth. DO NOT use combustible materials such as sawdust. Dispose of according to local, state (provincial) and federal regulations. Do not incinerate closed containers.

## Section 7 - Handling And Storage

Handling: Wash thoroughly after handling. Wash hands before eating. Use only in a well-ventilated area. Follow all MSDS/label precautions even after container is emptied because it may retain product residues. Avoid breathing vapor or mist.

Storage: Do not store above 120 ° F. Store large quantities in buildings designed and protected for storage of NFPA Class I flammable liquids. Keep containers tightly closed. Isolate from heat, electrical equipment, sparks

and open flame. Contents under pressure. Do not expose to heat or store above 120 ° F.

## Section 8 - Exposure Controls / Personal Protection

Engineering Controls: Use process enclosures, local exhaust ventilation, or other engineering controls to control airborne levels below recommended exposure limits. Prevent build-up of vapors by opening all doors and windows to achieve cross-ventilation. Use explosion-proof ventilation equipment.
