Cancer of the lungs has been associated with titanium dioxide, and cancer of the lungs and silicosis have been associated with quartz (crystalline) silica. No exposure to titanium dioxide or quartz (crystalline) silica is anticipated during normal intended use of 3M Coated Abrasives and Surface Conditioning Products. No detectable levels of these materials were found when simulated grinding air sampling studies were conducted on analogous coated abrasive and surface conditioning constructions that contained similar to or greater concentrations of titanium dioxide and crystalline silica. Therefore, the health effects associated with titanium dioxide and quartz (crystalline) silica are not expected during the intended use of this product.

7.1 HANDLING
