Section 3 - Hazards Identification

*** Emergency Overview ***: High vapor concentrations can irritate eyes, nose and respiratory passages. Causes nose and throat irritation. Harmful if inhaled. Reports have associated repeated and prolonged occupational overexposure to solvents with permanent brain and nervous system damage. Overexposure to xylene in laboratory animals has been associated with liver abnormalities, kidney, lung, spleen, eye and blood damage as well as reproductive disorders. Effects in humans, due to chronic overexposure, have included liver, cardiac abnormalities and nervous system damage.

Section 4 - First Aid Measures

Section 7 - Handling And Storage

Handling: Use with adequate ventilation. Follow all MSDS/label precautions even after container is emptied because it may retain product residues. Wash thoroughly after handling. Wash hands before eating.

Storage: Keep container closed when not in use. Keep away from heat, sparks, flame and sources of ignition. Keep containers tightly closed. Isolate from heat, electrical equipment, sparks and open flame.

Section 8 - Exposure Controls / Personal Protection

Engineering Controls: Use process enclosures, local exhaust ventilation, or other engineering controls to control airborne levels below recommended exposure limits. Prevent build-up of vapors by opening all doors and windows to achieve cross-ventilation.

Respiratory Protection: A respiratory protection program that meets OSHA 1910.134 and ANSI Z88.2 requirements must be followed whenever workplace conditions warrant a respirator's use.
