Section 3 – Hazards Identification

Section 6 – Accidental Release Measures

Section 7 – Handling And Storage

Store large quantities in buildings designed and protected for storage of NFPA Class I flammable liquids. Contents under pressure. Do not expose to heat or store above $120\,^{\circ}$ F.
