
# INSTRUCTIONS

# SPECIFICATIONS: AWG 16/3 SJTW power cord. ELECTRICAL RATINGS: 10A/125V/1250W/60Hz.

### Installation:

- 1. Connect the two pieces of the yard stake together by screwing the lower stake (C) into the upper stake (B).
- 2. Attach the yard stake to the outlet (A) by screwing the stake assembly into the base of the outlet (A). Be sure to firmly tighten the stake assembly to the outlet (A) before installing into the ground.
- 3. Insert the stake 6 inches into the ground.
  - OPERATION: Once assembled, plug the yard stake into a grounded outlet (total wattage should not exceed 10 amp or 1,250 watts)
  - Lift the rotate the dial counterclockwise to the desired setting.

# **Troubleshooting**

Problem	Possible Cause	Corrective Action
Lights do not turn on, even when timer is in "On" position.	Lights are not in "ON" position, lights are not functioning, or timer is not receiving power.	Be sure that lights are functional by plugging them directly into the outlet. Be sure that lights are in "ON" position if they have their own switch. Be sure that the outlet that the timer is plugged into is active.
Lights do not turn off at the requested time.	(1) Check to see that the off position is set correctly on timer dial.	(1) Confirm the dial is in the correct position by carefully listening for the clicking sound.
	(2) Other lights sources can affect the photocell operation. This can delay the lights turning off.	(2) Please move other lights source away from timer to ensure your timer will work properly.

### Installation:
