## 0. GENERAL INFORMATION

This Safe Use Instruction Sheet is the document provided by Owens Corning to communicate safe handling and use instructions for manufactured articles neither regulated by OSHA Hazard Communication Standard, 29 CFR 1910.1200 nor by the Canada Hazardous Products Regulation SOR/2015-17 (WHMIS 2015)

## 2. HAZARDS IDENTIFICATION

<b>OSHA Regulatory Status</b>	This product is considered an article. 29 CFR 1910.1200(c) definition of an article is as follows: "Article" means a manufactured item other than a fluid or particle: (i) which is formed to a specific shape or design during manufacture; (ii) which has end use function(s) dependent in whole or in part upon its shape or design during end use; and (iii) which under normal conditions of use does not release more than very small quantities, e.g., minute or trace amounts of a hazardous chemical (as determined under paragraph (d) of this section), and does not pose a physical hazard or health risk to employees This chemical is not considered hazardous by the 2012 OSHA Hazard Communication Standard (29 CFR 1910.1200).
<b>WHMIS Regulatory Status</b>	This product is considered an article per the Canadian Hazardous Products Regulation SOR/2015-17 Manufactured articles which meet the definition of the Canadian Hazardous Products Act (any article that is formed to a specific shape or design during manufacture, the intended use of which when in that form is dependent in whole or in part on its shape or design, and that, when being installed, if the intended use of the article requires it to be installed, and under normal conditions of use, will not release or otherwise cause an individual to be exposed to a hazardous product) are not regulated by the Canadian Hazardous Products Regulation SOR/2015-17
<b>Other Hazards</b>	May cause temporary skin and mucous membranes itching due to the mechanical abrasion

effect of fibers

### 3. COMPOSITION/INFORMATION ON INGREDIENTS

While mineral wool may cause temporary skin and mucous membranes itching due to the mechanical abrasion effects of fibers, it does not meet the new classification definition of "irritant" contained in the OSHA HCS 29 CFR 1910.1000, Appendix A. OSHA now specifically defines an irritant as "a reversible inflammatory effect on living tissue by chemical action..." Owens Corning mineral wool is an inert material and does not interact chemically with the skin or mucous membranes

| <b>Eye contact</b>  | <ul style="list-style-type: none"> <li>• DO NOT rub or scratch eyes</li> <li>• Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes</li> <li>• If eye irritation persists: Get medical advice/attention</li> </ul>  |
| <b>Skin contact</b> | <ul style="list-style-type: none"> <li>• Wash off immediately with soap and plenty of cold water</li> <li>• DO NOT use warm water because this will open up the pores of the skin, which will cause further penetration of the fibers</li> <li>• Use a wash cloth to help remove fibers</li> <li>• DO NOT rub or scratch affected area</li> <li>• Remove contaminated clothing and shoes</li> <li>• If fibers are seen penetrating from the skin, the fibers can be removed by applying and removing adhesive tape so that the fibers adhere to the tape and are pulled out of the skin</li> <li>• If skin irritation persists, call a physician</li> <li>• Never use compressed air to remove fibers from skin</li> </ul> |
| <b>Inhalation</b>   | <ul style="list-style-type: none"> <li>• Remove to fresh air</li> <li>• If symptoms persist, call a physician</li> </ul>   |
| <b>Ingestion</b>    | <ul style="list-style-type: none"> <li>• Accidental ingestion of this material is unlikely</li> <li>• Rinse mouth with water and drink water to remove fibers from the throat</li> <li>• If this does occur watch person for several days to make sure intestinal blockage does not occur</li> <li>• If symptoms persist, call a physician</li> </ul>  |
