**EFFECTS OF OVEREXPOSURE - CHRONIC HAZARDS:** Contains carbon black. Chronic inflammation, lung fibrosis, and lung tumors have been observed in some rats experimentally exposed for long periods of time to excessive concentrations of carbon black and several insoluble fine dust particles.
