EFFECTS OF OVEREXPOSURE - SKIN CONTACT: Causes skin irritation. Allergic reactions are possible.

EFFECTS OF OVEREXPOSURE - INHALATION: No hazard in normal residential usage. When incorporated in the liquid paint, pigments or extenders pose a minimal risk of exposure. Sanding or abrading the dried paint film increases the risk of exposure. Proper respiratory protection MUST be worn when sanding or abrading surfaces painted with this product.

EFFECTS OF OVEREXPOSURE - CHRONIC HAZARDS: Prolonged inhalation of Iron Oxide dust is known to produce a condition known as siderosis. On X-rays it appears to be a benign pneumoconiosis and is not associated with pulmonary fibrosis or disability unless there is a concurrent exposure to other fibrosis-producing materials such as silica.
