Section 5. Fire-fighting measures

Extinguishing media

Suitable extinguishing media

: Use an extinguishing agent suitable for the surrounding fire.

Unsuitable extinguishing

: None known.

Specific hazards arising from the chemical

: Extremely flammable aerosol. Runoff to sewer may create fire or explosion hazard. Large spill
