# 4. First-Aid Measures

Risk of overexposure depends on duration and level of exposure to dust from repeated sanding of surfaces or spray mist and the actual concentration of Titanium Dioxide in the formula. (Ref: IARC Monograph, Vol. 93, 2010)Contains residual amounts of vinyl acetate. IARC list vinyl acetate as a possible human carcinogen (Group 2B). This means there is inadequate evidence of carcinogenicity of vinyl acetate in humans and limited evidence of vinyl acetate in experimental animals. Risk of cancer depends on duration and exposure and actual concentration of vinyl acetate in the formula. Contains carbon black. Chronic inflammation, lung fibrosis, and lung tumors have been observed in some rats experimentally exposed for long periods of time to excessive concentrations of carbon black and several insoluble fine dust particles. Significant exposure is not anticipated during brush application or drying. Risk of overexposure depends on duration and level of exposure to dust from repeated sanding of surfaces or spray mist and the actual concentration of carbon black in the formula.
