SECTION 4: FIRST AID MEASURES

4.1. Description of First-aid Measures

This product contains carbon black, and is black is not expected to be released and bioavailable. If product is dried, processed, and dust is released carbon black particles may become inhalable. If dust is inhaled this product is suspected of causing cancer.

4.3. Indication of Any Immediate Medical Attention and Special Treatment Needed

SECTION 5: FIRE-FIGHTING MEASURES
