### SECTION 4. FIRST AID MEASURES

- General advice : Call a poison control center or doctor for treatment advice. For 24-hour emergency medical assistance, call Arch Chemical Emergency Action Network at 1-800-654-6911. ### SECTION 6. ACCIDENTAL RELEASE MEASURES
