## 4. First-Aid Measures

**FIRST AID - EYE CONTACT:** Immediately flush eyes with plenty of water for at least 15 minutes holding eyelids open. Get medical attention. Do NOT allow rubbing of eyes or keeping eyes closed.

## 5. Fire-Fighting Measures

**UNUSUAL FIRE AND EXPLOSION HAZARDS:** Water spray may be ineffective. Closed containers may explode when exposed to extreme heat due to buildup of steam. #### 6. Accidental Release Measures

# 7. Handling and Storage

#### PERSONAL PROTECTION
