# Specific hazards arising from the chemical

Extremely flammable aerosol. Runoff to sewer may create fire or explosion hazard. #### Personal precautions, protective equipment and emergency procedures

For non-emergency personnel

In the case of aerosols being ruptured, care should be taken due to the rapid escape of the pressurized contents and propellant. ### Large spill
