# 4. First-Aid Measures

## 6. Accidental Release Measures

# 7. Handling and Storage

#### PERSONAL PROTECTION

# 10. Stability and Reactivity

Conditions to Avoid: Avoid temperatures above 120°F (49°C). Avoid all possible sources of ignition.

Significant exposure is not anticipated during brush application or drying.
