



## 2170 • For Decks, Siding & Fencing

**Product Description & Use:** Peel Away® Deck Brightener and Neutralizer is a concentrated safe product for brightening unfinished exterior wood decking, siding, shakes and furniture. It rinses easily with water, and is safe for all coatings and treated lumber. **Peel Away®** Brightener / Neutralizer removes tannin and rust stains and eliminates the "mill glaze" on new planed lumber and siding. **Peel Away®** Brightener / Neutralizer will also reduce the pH levels of the **Peel Away®** Deck Stripper and Restorer. **This product is available in Gallons.** 

**Limitations:** Product efficiency is greatly reduced when air and surface temperature is below 50° F.

**Test Area:** Test an inconspicuous area and allow drying thoroughly before general use.

**Coverage:** This product can be diluted at a ratio of **7:1** and will cover between 1,600 and 2,400 square feet per gallon.

**Application:** To clean, brighten, remove mill glaze, and lower the pH of wood siding, decks, and fences.

- 1. Apply diluted solution (see above for dilution) liberally with a plastic, pump style garden sprayer. On vertical surfaces, start from the bottom and work up. DO NOT APPLY TO HOT SURFACES OR IN DIRECT SUNLIGHT.
- 2. Allow Brightener & Neutralizer to stand approximately 5-15 minutes. **DO NOT ALLOW BRIGHTENER & NEUTRALIZER TO DRY.** If the Brightener & Neutralizer dries, mist with water or reapply Brightener & Neutralizer.
- 3. Agitate surface with a stiff brush or power washer. **NOTE:** To avoid surface damage, if using a power washer, **DO NOT EXCEED 1000 PSI OR A 40 DEGREE TIP.** After surface is cleaned, thoroughly rinse surface and allow drying. Additional application may be necessary for desired results.
- 4. Allow surface to dry thoroughly before applying

a new finish. Lightly sanding the surface will help with penetration and adhesion of the new coatings.

**Dilution Guide:** NEVER MIX BRIGHTENER & NEUTRALIZER IN METAL CONTAINERS. DILUTE WITH 7 GALLONS OF WATER TO 1 GALLON OF BRIGHTENER & NEUTRALIZER. A power washer's chemical injector will automatically reduce this product at a 7 to 1 ration and does not need to be diluted before inserting chemical injector into the container.

Health & Safety: CAUTION: Wear safety goggles and/or face shield. Wear butyl gloves, impervious apron, boots and other clothing are recommended if needed, to prevent contact. If spraying (only outdoors), use a NIOSH approved organic vapor/dust mist respirator with appropriate eye protection. Do not mix or use with other household cleaners or chemicals. All surfaces must be thoroughly rinsed, dry and neutralized prior to staining or coating. Brightener & neutralizer residue will adversely affect stain or coating. Exercise caution when working on surfaces that are wet, especially from Brightener & Neutralizer. Wet surfaces are extremely slippery.
