# Section 3 - Hazards Identification

\*\*\* Emergency Overview \*\*\*: Contents Under Pressure. Harmful if inhaled. May affect the brain or nervous system causing dizziness, headache or nausea. Vapors may cause flash fire or explosion. Extremely flammable liquid and vapor. Harmful if swallowed.

Effects Of Overexposure - Eye Contact: Causes eye irritation.

## Section 6 - Accidental Release Measures

Steps To Be Taken If Material Is Released Or Spilled: Dispose of according to local, state (provincial) and federal regulations. Do not incinerate closed containers. # Section 7 - Handling And Storage

flammable liquids. Contents under pressure. Do not expose to heat or store above 120 degrees F.
