## 2. Hazard Identification

**EMERGENCY OVERVIEW:** Harmful if swallowed. Extremely flammable liquid and vapor. Vapors may cause flash fire or explosion. Contents Under Pressure. Harmful if inhaled. May affect the brain or nervous system causing dizziness, headache or nausea.

EFFECTS OF OVEREXPOSURE - EYE CONTACT: Causes eye irritation.

**EFFECTS OF OVEREXPOSURE - SKIN CONTACT:** Substance may cause slight skin irritation. Prolonged or repeated contact may cause skin irritation.

**EFFECTS OF OVEREXPOSURE - INHALATION:** Harmful if inhaled. High gas, vapor, mist or dust concentrations may be harmful if inhaled. Avoid breathing vapors or mists. High vapor concentrations are irritating to the eyes, nose, throat and lungs.

Effects in humans, due to chronic overexposure, have included liver, cardiac abnormalities and nervous system damage. IARC lists Ethylbenzene as a possible human carcinogen (group 2B). Contains Titanium Dioxide. Titanium Dioxide is listed as a Group 2B-"Possibly carcinogenic to humans" by IARC. Significant exposure is not anticipated during brush application or drying. Risk of overexposure depends on duration and level of exposure to dust from repeated sanding of surfaces or spray mist and the actual concentration of Titanium Dioxide in the formula. May cause central nervous system disorder (e.g., narcosis involving a loss of coordination, weakness, fatigue, mental confusion, and blurred vision) and/or damage. Reports have associated repeated and prolonged occupational overexposure to solvents with permanent brain and nervous system damage.

# 4. First-aid Measures

FURST AID EXE SONTACT: Immediately flush eyes with plenty of water for at least 15 minutes holding eyelids open. Get medical attention. Do NOT allow rubbing of eyes or keeping eyes closed.

# 7. Handling and Storage

**STORAGE:** Keep containers tightly closed. Isolate from heat, electrical equipment, sparks and open flame. Do not store above 120 ° F. Store large quantities in buildings designed and protected for storage of NFPA Class I flammable liquids. Contents under pressure. Do not expose to heat or store above 120 ° F.

# 8. Exposure Controls/Personal Protection

**ENGINEERING CONTROLS:** Use process enclosures, local exhaust ventilation, or other engineering controls to control airborne levels below recommended exposure limits. Use explosion-proof ventilation equipment. Prevent build-up of vapors by opening all doors and windows to achieve cross-ventilation.

**RESPIRATORY PROTECTION:** A respiratory protection program that meets OSHA 1910.134 and ANSI Z88.2 requirements must be followed whenever workplace conditions warrant a respirator's use.
